

PUBLIC HEARING

The Rockport Planning Board will hold a public hearing, pursuant to the requirements of M.G.L., Ch. 40A, §5, on Thursday, January, 26, 2017 at 7:35 p.m. in Conference Room A, Rockport Town Hall at 34 Broadway pertaining to an article (initiated by the Rockport Department of Public Works) to be presented at the Spring 2017 Town Meeting, that would amend the Town of Rockport Zoning By-law ("the Bylaw"), and, would modify the Town of Rockport Zoning District Map ("the Map"), to respectively designate and depict a Sewer Overlay District that would delimit the areas of Rockport to be served by the current sewer system. The text of the Zoning Bylaw amendment and a map depicting the boundaries of the proposed Sewer Overlay District are available for public review at the Town Clerk's office in the Rockport Town Hall at 34 Broadway and in the Planning Board office in the Town Hall Annex at 26 Broadway during business hours.
